Following Completion, IBIL ceased to have an interest in the FPL Transfer Shares.

IBIL is a wholly-owned subsidiary of International Beverage Holdings Limited, which is in turn a wholly-owned subsidiary of ThaiBev. Siriwanan has a direct interest of approximately 20.60% in ThaiBev. Siriwanan is a wholly-owned subsidiary of Siriwana, and Siriwana itself directly holds approximately 45.24% of ThaiBev's shares. Shiny Treasure holds approximately 49% of Siriwana's shares. Shiny Treasure has therefore ceased to have an interest in the FPL Transfer Shares.
