United Overseas Bank Limited (the "Company"), wishes to announce that it intends to issue Eur500 million 0.25% Covered Bonds due 2021 (the "Covered Bonds"). The Covered Bonds will be issued as the first series under the US\$8 billion Global Covered Bond Programme (the "Covered Bond Programme"). United Overseas Bank Limited, BNP Paribas, Commerzbank Aktiengesellschaft, DZ BANK AG Deutsche Zentral–Genossenschaftsbank, Frankfurt am Main, HSBC France, Natixis and UBS Limited have been appointed as managers for the Covered Bonds.

The Company is pleased to announce that it has priced the offering of the Covered Bonds and the principal terms of the Covered Bonds are as follows:

Issue Size: Eur500 million

Instrument: Eur Fixed Rate Covered Bonds

Issue Price: 99.653% of the principal amount of the Covered Bonds

Coupon: 0.25% per annum payable annually in arrear

Currency: Euros





Guarantee: The Covered Bonds will be guaranteed as to payments of interest

and principal by Glacier Eighty Pte. Ltd. (the "CBG"). The guarantee is secured by a portfolio of loans purchased by CBG

from the Company and other assets of CBG

Ratings: The Covered Bonds are expected to be rated Aaa by Moody's

Investors Service and AAA by Standard & Poor's Rating Services

Maturity Date: It is intended that the Covered Bonds will mature on 9 March

2021
