1. Issuance of the Tranche 1 Notes

The Board of Directors (the "**Board**") of Magnus Energy Group Ltd. (the "**Company**") wishes to announce that an aggregate amount of S\$3,000,000 of the Tranche 1 Notes have been duly issued to the Subscriber as at 9 April 2015 in accordance with the terms and conditions of the Notes Issue.

The Company will make further announcements on the utilisation of the net proceeds from the Notes Issue as and when the proceeds are materially disbursed.

2. Allotment and issue of Shares pursuant to the conversion of the Tranche 1 Notes

The Board wishes to announce that the Subscriber has, on 9 April 2015, exercised its rights to convert two (2) Notes (Certificate Nos. 059 to 060) in respect of the Tranche 1 Notes. The converted Notes, with an aggregate principal value of S\$100,000 will be converted into 52,631,578 Conversion Shares at the Floating Conversion Price of S\$0.0019 for each Conversion Share on 9 April 2015.

The Floating Conversion Price of S\$0.0019 was determined by taking 90% of the of the average of the traded volume weighted average prices per share for any three (3) consecutive Trading Days as selected by the Subscriber during the 30 Trading Days immediately preceding the relevant Conversion Notice dated, 9 April 2015. The three (3) consecutive Closing Prices per Share selected are as follows:
