AMENDMENTS TO THE TRUST DEEDS AND STAPLING DEED – PROPOSED SUPPLEMENTS TO THE TRUST DEEDS OF FRASERS HOSPITALITY REAL ESTATE INVESTMENT TRUST AND FRASERS HOSPITALITY BUSINESS TRUST AND THE STAPLING DEED OF FRASERS HOSPITALITY TRUST

Frasers Hospitality Asset Management Pte. Ltd., as manager (the "REIT Manager") of Frasers Hospitality Real Estate Investment Trust ("FH-REIT") and Frasers Hospitality Trust Management Pte. Ltd., as trustee-manager (the "Trustee-Manager", and collectively with the REIT Manager, the "Managers") of Frasers Hospitality Business Trust ("FH-BT"), had on 24 January 2018 announced the results of the annual general meeting ("AGM") of the stapled securityholders (the "Stapled Securityholders") of Frasers Hospitality Trust ("FHT") (a stapled group comprising FH-REIT and FH-BT) held on the same day, including the passing of an extraordinary resolution in respect of the provisions regarding electronic communications and transmission of notices and documents to Stapled Securityholders in the manner set out in Annexes A, B and C of the Appendix to the Notice of AGM dated 27 December 2017 (the "Appendix").

The Managers wish to announce that:

- (i) a third supplemental deed has been entered into on 24 January 2018 between the REIT Manager and Perpetual (Asia) Limited, in its capacity as trustee of FH-REIT (the "REIT Trustee"), to amend the deed of trust dated 12 June 2014 constituting FH-REIT, as amended, restated or supplemented from time to time, in accordance with Annex A of the Appendix (the "Third FH-REIT Supplemental Deed");
- (ii) a third supplemental deed has been entered into on 24 January 2018 by the Trustee-Manager, to amend the deed of trust dated 20 June 2014 constituting FH-BT, as amended, restated or supplemented from time to time, in accordance with Annex B of the Appendix (the "Third FH-BT Supplemental Deed"); and
- (iii) a first supplemental deed has been entered into on 24 January 2018 between the REIT Manager, the REIT Trustee and the Trustee-Manager, to amend the stapling deed dated 20 June 2014, in accordance with Annex C of the Appendix (the "First Supplemental Stapling Deed").

The Third FH-REIT Supplemental Deed, the Third FH-BT Supplemental Deed and the First Supplemental Stapling Deed will be available for inspection at the registered office of the Managers for so long as FH-REIT, FH-BT and FHT are in existence.
