SFRS(I) 16 Leases is effective for financial years beginning on or after 1 January 2019. The Group has applied the simplified transition approach and will not restate comparative amounts for the year prior to first adoption.

SFRS(I) 16 has resulted in most of the leases being recognised on the Statement of Financial Position, as the distinction between operating and finance leases is removed. Under the new standard, it requires a lessee to recognise a right-of-use ("ROU") asset representing its right to use the underlying asset and a lease liability representing its obligation to make lease payments. The only exceptions are short-term leases and leases of low value assets. The accounting for lessors has not changed significantly.

ROU assets are measured using the cost model and are carried at cost less accumulated depreciation and accumulated impairment loss, if any, subsequent to initial recognition. The carrying amount for lease liabilities subsequent to initial recognition would take into account interest on the lease liabilities, lease payments made and any reassessment or lease modifications.

The Group registered total revenue of \$\$22.4m for 2nd Quarter ended 30 June 2019 ("2Q FY2019") which was 11.5% lower than that of 2nd Quarter ended 30 June 2018 ("2Q FY2018"). Total revenue of \$\$34.7m for 1H FY2019 was 20.5% lower as compared to 1H FY2018, mainly due to lower trading and rental revenue.

Revenue from Equipment Rental business decreased by 28.9% to S\$7.7m in 2Q FY2019 and 31.6% to S\$14.8m in 1H FY2019 as compared to the corresponding periods in FY2018 respectively, mainly due to decrease in rental revenue and rental rates.

Revenue from Trading business increased by 1.5% to S\$14.7m in 2Q FY2019 but decreased by 9.6% to S\$19.9m in 1H FY2019 as compared to the corresponding periods in FY2018 respectively, mainly due to decrease in number of cranes delivered in 1H FY2019.

The Group registered total gross profit of S\$2.1m in 2Q FY2019, which was 56.0% lower than 2Q FY2018. Total gross profit for 1H FY2019 was S\$3.4m and 57.9% lower as compared to 1H FY2018.

Gross profit from Equipment Rental business decreased by 71.0% to \$\$1.0m in 2Q FY2019 and 70.8% to \$\$1.8m in 1H FY2019 as compared to the corresponding periods in FY2018. This is in line with the lower rental revenue generated.

Gross profit from Trading business decreased by 13.6% to \$\$1.1m in 2Q FY2019 and decreased by 18.5% to \$\$1.6m in 1H FY2019 as compared to the corresponding periods in FY2018, mainly due to a decrease in number of cranes delivered during the periods.

Net Profit / (Loss)

The Group registered net loss of S\$1.7m for 1H FY2019. This was mainly due to the net impact of the following:

- (a) lower revenue and gross profit generated from both equipment rental and trading businesses;
- (b) partially offset by medical insurance claims received in 1Q FY2019;
- (c) lower selling and administrative expenses;
- (d) lower financing costs;

STATEMENT OF FINANCIAL POSITION

Current assets

As at 30 June 2019, current assets amounted to \$\$53.8m or 36.1% of total assets. Current assets comprised mainly cash and bank balances, trade and other receivables and inventories. Total current assets increased by \$\$9.3m as compared to 31 December 2018 mainly due to increase in trade and other receivables and inventories.

Non-current assets

As at 30 June 2019, non-current assets amounted to \$\$95.1m or 63.9% of total assets. Non-current assets comprised mainly property, plant and equipment and right-of-use assets following the adoption of SFRS(I)16, Total non-current assets decreased by \$\$11.8m mainly due to decrease in rental fleet and depreciation charged for the period.

Current liabilities

As at 30 June 2019, current liabilities amounted to \$\$22.9m or 60.0% of total liabilities. Current liabilities comprised mainly bills payable, trade and other payables, current portion of bank loans, lease liabilities and finance leases. Total current liabilities increased by \$\$2.9m as compared to 31 December 2018, mainly due to increase in bank loans.

Non-current liabilities

As at 30 June 2019, non-current liabilities amounted to approximately \$\$15.2m or 40.0% of total liabilities. Non-current liabilities comprised mainly non-current portion of lease liabilities, finance leases and deferred tax. Total non-current liabilities decreased by \$\$3.3m as compared to 31 December 2018, mainly due to repayment of finance leases.

Working Capital

As at 30 June 2019, the Group registered a positive working capital of S\$30.9m as compared to that of S\$24.5m as at 31 December 2018.

Equity

As at 30 June 2019, the Group's equity was lower at S\$110.8m as compared to S\$112.9m as at 31 December 2018, mainly due to loss recorded for 1HFY2019.
