Unity is wholly owned by Dr. T.C. Pierre (Cayman Island) Inc., which is wholly owned by SG Kleinwort Hambros Trust Company (Channel Islands) Limited as trustee of the TC Peter MD Settlement.

Dr Cheo Tong Choon @ Lee Tong Choon is deemed interested as he is the settlor of the TC Peter MD Settlement. The total quantum of interests in securities held by Dr Cheo Tong Choon @ Lee Tong Choon remains unchanged.
