On 3 June 2015, CK Global Investments Limited ("CK Global"), a company incorporated in the British Virgin Islands with limited liability, has become the immediate holding company of HWL pursuant to a share exchange offer under a scheme of arrangement in Hong Kong.

Relationship between Substantial Unitholders

Hutchison Port Group Holdings Limited ("HPGH") holds 2,406,227,022 units in Hutchison Port Holdings Trust ("HPH Trust"). HPGH is a wholly-owned subsidiary of Hongkong and Whampoa Dock Company, Limited which in turn is a wholly-owned subsidiary of HWDC Holdings Limited ("HWDC"). HWDC is a wholly-owned subsidiary of Whampoa Dock Holdings Limited which in turn is a wholly-owned subsidiary of Hutchison International Limited ("HIL"). HIL is a wholly-owned subsidiary of HWL which in turn is 50.03% directly owned by CK Global.

As such, CK Global is deemed to be interested in 2,406,227,022 units in HPH Trust held by HPGH and CK Global has become a new Substantial Unitholder of HPH Trust.
