#### PARTICIPATION IN ANNUAL GENERAL MEETING ("AGM") BY ELECTRONIC MEANS

- 1. Background: Envictus International Holdings Limited (the "Company") refers to:
  - a) the Notice of Annual General Meeting issued on 9 February 2021 ("AGM Notice") to convene the Annual General Meeting for FY2020 ("AGM") of the Company to be held on Thursday, 11 March 2021 at 11.00 a.m.;
  - b) the implementation of the circuit breaker measures (enhanced safe distancing measures and closure of workplace premises) announced by the Government on 3 April 2020 to curb the further spread of COVID-19;
  - c) the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020 ("Order") which provides, among others, legal certainty to enable issuers to make alternative arrangements to hold general meetings where personal attendance is required under written law or legal instruments (e.g. a company's constitution);
  - d) the joint statement by the Accounting and Corporate Regulatory Authority, the Monetary Authority of Singapore and the Singapore Exchange Regulations on 13 April 2020 providing additional guidance for issuers on the conduct of general meetings during elevated safe distancing period; and
  - e) the press release by the Ministry of Law (Singapore) on 7 September 2020 regarding the planned extension of, amongst others, the Order, to 30 June 2021, providing entities with the option to hold virtual meetings even where the entities are permitted under safe distancing regulations to hold physical meetings.
- 2. Date, time and conduct of AGM: Pursuant to the Order the Company's AGM will be convened and held by way of electronic means on Thursday, 11 March 2021 at 11.00 a.m. (Singapore time)
- 3. Annual Report 2020, Notice of AGM and Proxy Form: All documents which relate to the business of AGM are published on SGXNet at URL <a href="https://www.sgx.com/securities/company-announcements">https://www.sgx.com/securities/company-announcements</a> and the Company's website at the URL <a href="https://www.envictus-intl.com">https://www.envictus-intl.com</a>. Printed copies of these documents will not be despatched to Shareholders. Shareholders are advised to check SGXNet and/or the Company's website regularly for updates.
- 4. No personal attendance at the AGM: Due to the current COVID-19 restriction orders in Singapore, Shareholders will not be able to attend the AGM in person.
- 5. Participation at the AGM electronically: Shareholders may participate at the AGM by:
  - a) observing and/or listening to the AGM proceedings via "live" audio visual webcast via their mobile phones, tablets or computers or "live" audio-only stream via telephone;
  - b) submitting questions in advance of the AGM; and/or
  - c) appointing the Chairman of the AGM ("Chairman") as proxy to attend, speak and vote on their behalf at the AGM.

Details of steps for pre-registration, pre-submission of questions and voting at the AGM are set out in the **Appendix** to this announcement.

# 6. Persons who hold shares through relevant intermediaries (as defined in Section 181 of the Companies Act (Chapter 50 of Singapore)):

- a) CPF and SRS investors who wish to participate in the AGM by (i) observing and/or listening to the AGM proceedings via "live" audio-visual webcast or "live" audio-only stream; and (ii) submitting questions in advance of the AGM, should follow the steps for pre-registration and pre-submission of questions set out in the **Appendix** to this Announcement. However, CPF and SRS investors who wish to appoint the Chairman as proxy to attend, speak and vote on their behalf should approach their respective CPF Agent Banks or SRS Operators to submit their voting instructions by **11.00 a.m. on 1 March 2021.**
- b) Investors holding shares through relevant intermediaries, who are not CPF or SRS investors, who wish to participate in the AGM by (i) observing and/or listening to the AGM proceedings via "live" audio-visual webcast or "live" audio-only stream; (ii) submitting questions in advance of the AGM; and/or (iii) appointing the Chairman as proxy to attend, speak and vote on their behalf at the AGM, should contact their relevant intermediary soonest in order to make the necessary arrangements for them to participate in the AGM.
