PROPOSED DIVESTMENT OF A PROPERTY IN MALAYSIA

Singapore, 3 January 2025 – Mapletree Logistics Trust Management Ltd., as manager (the “Manager”) of Mapletree Logistics Trust (“MLT” or the “Trust”), would like to announce that HSBC Institutional Trust Services (Singapore) Limited (in its capacity as trustee of MLT) has, through its special purpose vehicle in Malaysia, entered into a conditional Sale and Purchase Agreement with an unrelated third party for the proposed divestment of Subang 2 in Malaysia at a sale price of MYR31.5 million or approximately S\$9.6 million¹ (the “Divestment”).

The Divestment is in line with the Manager’s efforts to rejuvenate its portfolio through selective divestment of assets that are no longer aligned with its strategy. Capital released from the divestment will provide MLT with greater financial flexibility to pursue investment opportunities in high specification, modern logistics facilities with higher growth potential.

Located in Subang, Selangor, Subang 2 comprises a single-storey warehouse and an annex three-storey office with a building age of over 27 years. It has a net lettable area of 8,297 square metres (“sqm”) on a land site of approximately 12,100 sqm. The sale price of MYR31.5 million is 31.3% above the latest valuation of MYR24.0 million as at 31 October 2024.

The Divestment is expected to be completed in the first half of FY25/26. It is not expected to have a material impact on MLT’s net asset value and net property income for FY25/26. Following the divestment, MLT’s portfolio will consist of 178 properties².

As at 30 September 2024, it has a portfolio of 186 properties in Singapore, Australia, China, Hong Kong SAR, India, Japan, Malaysia, South Korea and Vietnam with assets under management of S\$13.4 billion.
