AWARD OF S\$4.63 MILLION CONTRACT BY THE CHANGI AIRPORT GROUP FOR PROVISION OF SOIL INVESTIGATION SERVICES

The Board of Directors (“**Directors**”) of Trittech Group Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) wishes to announce that its wholly-owned subsidiary, Trittech Engineering & Testing (Singapore) Pte. Ltd. (“**Trittech Engineering**”), had on 12 June 2018, been awarded a S\$4,629,521 contract, “Provision of Soil Investigation Services for Terminal 5 Building for Singapore Changi Airport” (the “**Contract**”) by the Changi Airport Group (Singapore) Pte Ltd (“**CAG**”).

The scope of the Contract including, *inter alia*, the provision of soil investigation services at Changi Airport (the “**Services**”) and the key terms of the Contract are as follows:-

- To provide all professional and technical personnel, labour, materials, plant and everything necessary for the proper execution of the Services;
- To supply all necessary shoring, platform, geotechnical investigation and construction equipment, plant and tools required for the Services, properly maintained and calibrated for use and removed on completion of the Services;
- Carrying out geotechnical investigations on land; performing associated field and laboratory tests, and presenting all field and laboratory data in factual reports in a format acceptable to CAG;
- Submitting all acquired information and test results in a format acceptable to CAG; and
- All other works and services ancillary or related to the full completion of the Services in accordance with CAG’s requirements.

The commencement date for the Services is 18 June 2018 and the completion date is 17 April 2020 (22 months), unless terminated earlier or extended as provided in the Conditions of Contract. There is no defects liability period.

Trittech Engineering is one of the largest site investigation specialists in Singapore and has extensive experience and know-how in site investigation in Singapore.

None of the Directors (other than in their respective capacities as a director and/or shareholder of the Company) or substantial shareholders of the Company (in so far as the Directors of the Company are aware) or their respective associates, have any interest, direct or indirect, in the Contract.

The Contract is not expected to have a material impact on the consolidated earnings per share and net tangible assets per share of the Group for the current financial year ending 31 March 2019.
