**1. INTRODUCTION**

The board of directors (the "**Board**") of F J Benjamin Holdings Ltd (the "**Company**") refers to the Announcements.

**2. ALLOTMENT AND ISSUANCE OF THE PLACEMENT SHARES**

Further to the Announcements, the Board is pleased to announce that the Company has received the entire Gross Proceeds of S\$705,600 and has, on 31 July 2026 (the "**Issuance Date**"), allotted and issued an aggregate of 112,000,000 Placement Shares at the Issue Price of S\$0.0063 per Placement Share to the Placees in accordance with the terms and conditions of the Placement Agreements. Accordingly, the Proposed Placement has been completed on the same day.

Following the completion of the Proposed Placement, the total number of issued Shares of the Company has increased from 1,229,313,903 Shares to 1,341,313,903 Shares. The Company has no treasury shares or subsidiary holdings.

The Placement Shares were allotted and issued free from all claims, pledges, mortgages, charges, third party rights, liens and any other encumbrances whatsoever and rank in all respects *pari passu* with the then existing issued Shares at the time of the issue with all rights and benefits attaching thereto save that they will not be entitled to any dividends, rights, allotments or other distributions, the record date for which falls on or before the date of the Issuance Date.

The LQN granted by the SGX-ST for the listing and quotation of the Placement Shares is not to be taken as an indication of the merits of the Proposed Placement, the Placement Shares, the Company, its subsidiaries, or its securities.

The Placement Shares are expected to be listed and quoted on the Catalist Board of the SGX-ST with effect from 9.00 a.m. on 5 August 2026.
