While Form C will be attached to the announcement template, it will not be disseminated to the public and is made available only to the Monetary Authority of Singapore (the "Authority").

As at 01 November 2017, after the granting of the 3rd Performance Share Award ("PSA"), the total number of share award comprises:-
 a) 1st PSA granted on 23 June 2015 - 164,900 shares (50% balance);
 b) 2nd PSA granted on 01 November 2016 - 469,700 shares (not yet vested); and
 c) 3rd PSA granted on 01 November 2017 - 588,000 shares (not yet vested).

The PSA is vested 50% three months after the end of the Performance Period* per annum, with the balance vesting one calendar year later. Shares will vest to the participant after the end of each relevant vesting period provided certain performance conditions are achieved in accordance with the rules of the Plan.

* The final number of shares released will depend on the achievement of pre-determined performance conditions at the end of a two-year Performance Period. No shares will be released if the threshold targets are not met at the end of the Performance Period, unless otherwise decided by the Remuneration Committee. On the other hand, if superior targets are met, more shares than the initial award could be delivered up to a maximum of 200% of the initial award.
