iWOW Maintains Top-line and is Confident of Robust 2H2024 Revenues, Backed by Record-High Order Book

- Continued focus on IoT-as-a-Service ("laaS") will create increasing stream of higher margin revenue going forward.
- iWOW remains confident of the outlook of its targeted markets, backed by a record-high order book of S\$100.4 million as of 31 October 2023.

SINGAPORE, 14 November 2023 – iWOW Technology Limited ("**iWOW**" or the "**Company**", and together with its subsidiaries, the "**Group**"), a home-grown technology provider specialising in integrated wireless IoT solutions as a service, is pleased to announce its financial results for the half-year ended 30 September 2023 ("**1H2024**").

iWOW's revenue for 1H2024 grew by a modest 1.2% Y-o-Y to reach S\$17.3 million, compared to S\$17.1 million in 1H2023. This growth was achieved despite a 96.8% Y-o-Y decline in revenue from its Smart City Solutions ("SCS") segment, primarily due to the absence of Trace Tokens

sales and a delay in tenders for expected projects. This was, however, offset by strong revenue contribution from the Smart City Infrastructure ("**SCI**") segment with a top-line contribution of S\$12.2 million in 1H2024.

Despite stable revenues in 1H2024, the Group witnessed an 88.2% Y-o-Y decline in net profit to S\$0.3 million. This is due to a shift in product mix and higher costs as a result of increased hiring to bolster the Group's R&D and business development capabilities. The Group's goal is to capture near-term growth opportunities and accelerate project completion.

Business Outlook

With a strong focus on R&D to continuously bolster its product and service offerings, iWOW is well-positioned to capture regional opportunities driven by robust tailwinds and megatrends in the current digitalisation era. Backed by a strong order book of \$100.4 million as of 31 October 2023, the Group is cautiously confident of its revenue performance for the half year ending 31 March 2024 ("2H2024").

The Group anticipates strong revenues from its Smart City Infrastructure segment in 2H2024, as it fulfils the bulk of the installation works for its contract as previously announced on 21 July 2023, which is valued at approximately S\$20.0 million, including 10 years of recurring maintenance services. The continual focus on growing the Group's higher-margin subscription-based business will allow iWOW to benefit from improving future earnings visibility.
