

PAYMENT OF MANAGEMENT FEES BY WAY OF ISSUE OF NEW UNITS IN ESR-REIT

ESR-REIT Management (S) Limited, the manager of ESR-REIT (the "**Manager**"), is pleased to announce that 14,543,269 new units in ESR-REIT ("Units") have been issued to the Manager (11,630,846 new Units) and ESR Property Services Pte. Ltd., the property manager of ESR-REIT (the "**Property Manager**") (2,912,423 new Units) today.

The new Units were allotted at an issue price of S\$0.2551 per Unit as partial payment for the Manager's base fees and the Property Manager's property management fees for the period from 1 October 2024 to 31 December 2024 ("**4Q2024**").

The issue price was determined based on the volume weighted average price per Unit for all trades on Singapore Exchange Securities Trading Limited in the ordinary course of trading for the last ten (10) business days of 4Q2024.

Following the above issuance of new Units, the total number of Units in issue is 8,056,207,484 of which the Manager's holding is 220,204,281 Units and the Property Manager's holding is 45,961,181 Units, representing 2.73% and 0.57% of the total number of Units in issue, respectively.
