Pursuant to the exercise of its right of compulsory acquisition under Section 215(1) of the Companies Act 1967 of Singapore (the "Compulsory Acquisition"), Dominus Capital Pte. Ltd. (the "Offeror") had on 28 March 2022 completed the Compulsory Acquisition of an aggregate of 10,036,052 issued and paid-up ordinary shares (the "Shares") in the capital of Koufu Group Limited (the "Company") at a consideration of \$0.77 in cash for each Share. Following the Compulsory Acquisition, the Offeror owns 552,955,300 Shares, representing 100% of the Shares in the Company.

The Shares owned by the Offeror are held in the name of its nominee, United Overseas Bank Nominee (Private) Limited.
