NOTICE IS HEREBY GIVEN that the Annual General Meeting of the Company will be held at 11 Tuas Link 1, Singapore 638588 on Monday, 28 April 2014 at 10.00 a.m. to transact the following business:-

AS ORDINARY BUSINESS

- To receive and adopt the Directors' Report and Audited Financial Statements of the Company for the financial year Resolution 1 ended 31 December 2013 together with the Auditor's Report thereon.
 To declare a final tax exempt dividend of 0.7 cents per share for the financial year ended 31 December 2013 (2012: final tax exempt dividend of 1.0 cents per share).
 To approve Directors' fees of \$\$146,000 for the financial year ending 31 December 2014 (2013: \$\$134,000).
- 4. To re-elect Mr Tan Bock Chia who is retiring pursuant to Article 104 of the Company's Articles of Association.
 Mr Tan Bock Chia will, upon re-election as a Director of the Company, continue to serve as Executive Director of the Company.

- 5. To re-elect Mr Chan Kam Loon who is retiring pursuant to Article 104 of the Company's Articles of Association. Resolution 5 Mr Chan Kam Loon will, upon re-election as a Director of the Company, continue to serve as the Lead Independent Director, Chairman of the Audit Committee and as members of the Remuneration Committee and Nominating Committee. Mr Chan is considered independent for the purpose of Rule 704(7) of the Listing Manual of the Singapore Exchange Securities Trading Limited Section B: Rules of Catalist (the "Catalist Rules"). Key information on Mr Chan Kam Loon is found on page 12 of the Company's 2013 annual report.
- 6. To re-elect Dr Tay Kin Bee will, upon re-election as a Director of the Company, continue to serve as member of the Audit Committee and Chairman of the Remuneration Committee. Dr Tay is considered independent for the purpose of Rule 704(7) of the Catalist Rules.

- 7. To re-appoint Messrs RSM Chio Lim LLP as auditors of the Company and to authorise the Directors to fix their **Resolution 7** remuneration.

AS SPECIAL BUSINESS

To consider and, if thought fit, to pass the following Ordinary Resolutions with or without any modifications:-

- 8. Authority to allot and issue shares and convertible securities
 - (a) "That pursuant to Section 161 of the Companies Act, Cap. 50, and the Catalist Rules, authority be and is hereby given to the Directors of the Company at any time to such persons and upon such terms and for such purposes as the Directors may in their absolute discretion deem fit, to:
 - (i) issue shares in the capital of the Company whether by way of rights, bonus or otherwise;
 - make or grant offers, agreements or options (collectively, "Instruments") that might or would require shares to be issued or other transferable rights to subscribe for or purchase shares including but not limited to the creation and issue of warrants, debentures or other instruments convertible into shares;
 - (iii) issue additional Instruments arising from adjustments made to the number of Instruments previously issued in the event of rights, bonus or capitalisation issues; and
 - (b) (notwithstanding the authority conferred by the shareholders may have ceased to be in force) issue shares in pursuance of any Instrument made or granted by the Directors while the authority was in force,

provided always that

(i) the aggregate number of shares to be issued pursuant to this resolution (including shares to be issued in pursuance of Instruments made or granted pursuant to this resolution) does not exceed 100% of the total number of issued shares excluding treasury shares of the Company, of which the aggregate number of shares (including shares to be issued in pursuance of Instruments made or granted pursuant to this resolution) to be issued other than on a pro rata basis to shareholders of the Company does not exceed 50% of the total number of issued shares excluding treasury shares of the Company. Unless prior shareholder approval is required under the Catalist Rules, an issue of treasury shares will not require further shareholder approval, and will not be included in the aforementioned limits.

For the purpose of this resolution, the total number of issued shares excluding treasury shares is based on the Company's total number of issued shares excluding treasury shares at the time this resolution is passed, after adjusting for;

- a) new shares arising from the conversion or exercise of convertible securities, or
- b) new shares arising from exercising share options or vesting of share awards outstanding or subsisting at the time this resolution is passed provided the options or awards were granted in compliance with Part VIII of Chapter 8 of the Catalist Rules, and
- c) any subsequent bonus issue, consolidation or subdivision of the Company's shares, and
- (ii) such authority shall, unless revoked or varied by the Company at a general meeting, continue in force until the conclusion of the next Annual General Meeting or the date by which the next Annual General Meeting of the Company is required by law to be held, whichever is the earlier."

- 1. The ordinary resolution in item no. 8 is to authorise the Directors of the Company from the date of the above Meeting until the next Annual General Meeting to issue shares and convertible securities in the Company up to an amount not exceeding in aggregate 100% of the issued share capital of the Company of which the total number of shares and convertible securities issued other than on a pro-rata basis to existing shareholders shall not exceed 50% of the issued share capital of the Company at the time the resolution is passed, for such purposes as they consider would be in the interests of the Company. This authority will, unless revoked or varied at a general meeting, expire at the next Annual General Meeting of the Company.
- 2. The ordinary resolution proposed in item 9 above, if passed, will empower the Directors of the Company to offer and grant options under the Megachem Employee Share Option Scheme and to allot and issue shares pursuant to the exercise of such options under the Megachem Employee Share Option Scheme not exceeding 15% of the issued share capital of the Company from time to time.
