The lead arrangers and lenders of the loan are DBS Bank Ltd., Oversea-Chinese Banking Corporation Limited, United Overseas Bank Limited, RHB Bank Bhd, Singapore Branch, The Bank of East Asia, Limited, Singapore Branch ("BEA") and The Hongkong and Shanghai Banking Corporation Limited ("HSBC").
- (ii) S\$45,000,000 facility agreement dated 21 September 2016 with BEA.
- (iii) S\$200,000,000 facility agreement dated 30 June 2017 with HSBC.
