INCREASE IN SHARE CAPITAL PURSUANT TO THE EXERCISE OF SHARE OPTIONS

The Board of Directors of Vicplas International Ltd (the **Company**) wishes to announce that on 16 March 2018 the Company has allotted and issued 1,250,000 ordinary shares in the capital of the Company at the exercise price of S\$0.115 each pursuant to the exercise of options granted under the Vicplas International Share Option Plan.

The above-mentioned new shares have been listed and quoted on the Singapore Exchange Securities Trading Limited on 20 March 2018.

The new shares issued rank *pari passu* in all respects with the existing ordinary shares of the Company in issue.

Following the allotment and issue of new shares, the number of issued and paid-up shares in the capital of the Company has increased to 504,927,699 ordinary shares (including treasury shares) and the issued and paid-up share capital has increased to S\$50,356,434.
