

ALLOTMENT AND ISSUANCE OF SHARES PURSUANT TO WARRANT EXERCISE

The Board of Directors (the "**Board**") of ValueMax Group Limited (the "**Company**") wishes to announce the number of issued ordinary shares of the Company has increased from 871,392,351 ordinary shares (exclusive of 100,000 treasury shares) to 915,564,361 ordinary shares by way of allotment and issuance 44,172,010 new ordinary shares in the capital of the Company pursuant to the exercise of 44,172,010 warrants at the exercise price of S\$0.36 each, on 29 April 2025.
