ANNUAL GENERAL MEETING OF NETLINK NBN TRUST ANNUAL GENERAL MEETING OF SINGAPORE NBN TRUST TO BE HELD ON 28 SEPTEMBER 2020

1. INTRODUCTION

The Board of Directors (the "**Board**") of NetLink NBN Management Pte. Ltd., in its capacity as Trustee-Manager of NetLink NBN Trust ("**NLNBNT**") refers to:

- (a) the announcement of 22 June 2020 on the automatic time extension of 60 days provided by SGX Regco and ACRA to issuers with financial year-ends on or before 31 March 2020 to hold their annual general meetings;
- (b) the COVID-19 (Temporary Measures) Act 2020 ("Covid Temporary Measures Act") passed by Parliament on 7 April 2020 which enables the Minister for Law by order to prescribe alternative arrangements for listed entities in Singapore to, inter alia, conduct general meetings, either wholly or partly, by electronic communication, video conferencing, tele-conferencing or other electronic means; and
- (c) the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) (Amendment No. 2) Order 2020 (the "Order") which was gazetted on 13 April 2020, and which sets out the alternative arrangements in respect of, inter alia, general meetings of business trusts ("Alternative Arrangements").

The Alternative Arrangements set out in the Order will apply to meetings convened, held and conducted from 27 March 2020 to 30 September 2020 (the "**Applicable Period**").

2. DATE OF ANNUAL GENERAL MEETING FOR NLNBNT AND SINGAPORE NBN TRUST ("TM SHARE TRUST")

The Board is pleased to announce that pursuant to the Order, the annual general meetings for NLNBNT and TM Share Trust will be convened and held by way of electronic means, on Monday, 28 September 2020 at 4.00 p.m. and 4.30 p.m. (Singapore time) respectively (collectively known as the "**AGMs**").

Our Board Chairman, Mr Chaly Mah Chee Kheong, and our CEO, Mr Tong Yew Heng, will conduct the proceedings of the AGMs. The Trustee-Manager will endeavour to address all substantial and relevant questions which unitholders of NLNBNT ("**Unitholders**") have submitted in advance and publish responses to these questions on NLNBNT's website and on SGXNet prior to the AGMs.

3. NO DESPATCH OF PRINTED COPY OF THE RESPECTIVE NOTICES OF AGM AND PROXY FORMS

The respective notices of AGM and proxy forms will be sent to Unitholders solely by electronic means via publication on NLNBNT's website and will also be made available on the SGX website¹. Printed copies of these documents will not be sent to Unitholders.

The Appendix to Unitholders in relation to the proposed Trust Deed Amendments is made available to Unitholders on 25 August 2020 together with the Notice of AGM via SGXNet and NLNBNT's website at the URL: https://www.netlinknbn.com/agm.html.

4. NO PERSONAL ATTENDANCE AT THE AGMS

<u>Unitholders will not be able to attend the AGMs in person</u>. Instead, alternative arrangements have been put in place to allow Unitholders to participate at the AGMs. Please see paragraph 5 below for these alternative arrangements.

5. ALTERNATIVE ARRANGEMENTS

Unitholders may participate at the AGMs by: (a) observing and/or listening to the proceedings at the AGMs via "live" audio-visual webcast or "live" audio-only stream; (b) submitting questions in advance of the AGMs; and/or (c) appointing the Chairman of the respective AGMs as proxy to attend, speak and vote on their behalf at the AGMs.

Details of the steps for pre-registration, pre-submission of questions and voting at the AGMs are set out in the Appendix to this announcement.

6. UNITHOLDERS WHO HOLD UNITS THROUGH RELEVANT INTERMEDIARIES

Unitholders who hold units in NLNBNT ("**Units**") through a relevant intermediary (as defined below), other than SRS investors, and who wish to participate in the AGMs by: (a) observing and/or listening to the AGMs proceedings via "live" audio-visual webcast or "live" audio-only stream; (b) submitting questions in advance of the AGMs; and/or (c) appointing the Chairman of the respective AGMs as proxy to attend, speak and vote on their behalf at the AGMs, should approach their respective relevant intermediaries through which they hold such Units as soon as possible in order to make the necessary arrangements for them to participate in the AGMs.

SRS investors who wish to appoint the Chairman of the AGMs as proxy should approach their SRS operators to submit their votes by 5.00 p.m. on 16 September 2020, being 7 clear working days before the date of the AGMs.

"relevant intermediary" means:

- (i) a banking corporation licensed under the Banking Act, Chapter 19 of Singapore or a wholly-owned subsidiary of such a banking corporation, whose business includes the provision of nominee services and who holds Units in that capacity; or
- (ii) a person holding a capital markets services licence to provide custodial services for securities under the Securities and Futures Act, Chapter 289 of Singapore and who holds Units in that capacity.

APPENDIX

Steps for pre-registration, pre-submission of questions and voting at the respective AGMs of NLNBNT and TM Share Trust:

Unitholders will be able to observe and/or listen to the respective AGM proceedings of NLNBNT and TM Share Trust through a "live" audio-video webcast or "live" audio-only stream via their mobile phones, tablets or computers, submit questions in advance of the AGMs and vote by appointing the Chairman of the respective AGMs as proxy to attend, speak and vote on their behalf at the respective AGMs of NLNBNT and TM Shares Trust to be held on 28 September 2020.

To do so, they will need to complete the following steps:

3	Submit proxy forms to vote	Appointment of Chairman of the respective AGMs as proxy: Unitholders (whether individual or corporate) who pre-register to observe and/or listen to the proceedings at the AGMs and wish to vote on the resolutions to be tabled at the AGMs must appoint the Chairman of the respective AGMs as their proxy to attend, speak and vote on their behalf at the respective AGMs, in accordance with the instructions on the respective proxy forms.
		Specific voting instructions to be given: Where Unitholders (whether individual or corporate) appoint the Chairman of the respective AGMs as their proxy, they must give specific instructions as to voting, or abstentions from voting, in respect of a resolution in the proxy form, failing which the appointment of the Chairman of the respective AGMs as proxy for that resolution will be treated as invalid.

		SRS investors who wish to appoint the Chairman of the AGMs as proxy should approach their SRS operators to submit their votes by 5.00 p.m. on 16 September 2020. Other persons holding Units through other relevant intermediaries who wish to vote should approach their relevant intermediaries as soon as possible to specify voting instructions.
		In view of the current COVID-19 situation and the related safe distancing measures which may make it difficult for Unitholders to submit completed proxy forms by post, Unitholders are strongly encouraged to submit completed proxy forms electronically via email.
