The Boards of Directors of M&C REIT Management Limited, as manager of CDL Hospitality Real Estate Investment Trust ("**H-REIT**") (the "**H-REIT Manager**"), and M&C Business Trust Management Limited, as trustee-manager of CDL Hospitality Business Trust ("**HBT**") (the "**HBT Trustee-Manager**"), wish to announce the following:

1. In compliance with the requirements of the definition of 'Independent Director' set out in the Securities and Futures (Licencing and Conduct of Business) Regulations issued by the Monetary Authority of Singapore, Ms Cheah Sui Ling will step down as an Independent Non-Executive Director ("**INED**") from the Boards of the H-REIT Manager and the HBT Trustee-Manager and her positions as the Chairman of Board Sustainability Committees ("**BSCs**"), a member of Audit and Risk Committees ("**ARCs**") and a member of Nominating and Remuneration Committees ("**NRCs**") of the H-REIT Manager and HBT Trustee-Manager with effect from 17 August 2026.

Further details on Ms Cheah's cessation which are required to be disclosed pursuant to Rule 704(7) of the Listing Manual of the Singapore Exchange Securities Trading Limited ("**SGX-ST**") will be released in a separate announcement to SGX-ST.

2. Ms Cheryl Seow Bee Lian has been appointed as an Independent Non-Executive Director and a member of ARCs of the H-REIT Manager and the HBT Trustee-Manager with effect from 17 August 2026.

The NRCs and the Boards of the H-REIT Manager and the HBT Trustee-Manager respectively consider Ms Seow to be independent and capable of exercising independent business judgment. Her extensive experience in the REIT sector, corporate finance and fund management will further complement and strengthen the core competencies and skills set of the Boards of the H-REIT Manager and the HBT Trustee-Manager.

Further details on Ms Seow's appointment which are required to be disclosed pursuant to Rule 704(7) of the Listing Manual of SGX-ST will be released in a separate announcement to SGX-ST.

3. Mr Yeo Wee Eng Vincent, an Executive Director and the Chief Executive Officer of the H-REIT Manager and the HBT Trustee-Manager, has been appointed as the Chairman of BSCs with effect from 17 August 2026 in place of Ms Cheah.
4. Mr Richard Anthony Johnson, an INED, has been appointed as a member of NRCs and BSCs with effect from 17 August 2026.
