### DESPATCH OF NOTICES OF ELECTION AND TAX DECLARATION FORMS PURSUANT TO THE DISTRIBUTION REINVESTMENT PLAN FOR 4Q FY2014/15 DISTRIBUTION PERIOD

7 May 2015 - Further to the announcements dated 22 April 2015 and 30 April 2015 by Mapletree Commercial Trust Management Ltd., as manager of Mapletree Commercial Trust (“MCT” and as manager of MCT, the “**Manager**”), in relation to the application of a distribution reinvestment plan (the “**DRP**”) to the distribution of 2.0 Singapore cents per unit in MCT (“**Unit**”) for the Fourth Quarter Financial Year 2014/15 from 1 January 2015 to 31 March 2015 (the “**4Q FY2014/15 Distribution**”), the Manager wishes to announce that the Notices of Election<sup>1</sup> and Tax Declaration Forms<sup>2</sup> have been despatched to all eligible persons registered as unitholders of MCT (“**Eligible Unitholders**”) in the Depository Register as at 5.00 p.m. on the book closure date of 30 April 2015 and with registered mailing addresses in Singapore.

Unitholders with registered addresses outside Singapore (“**Overseas Unitholders**”) who did not provide any address in Singapore for the services of notices and documents by notifying The Central Depository (Pte) Limited (“**CDP**”) by 24 April 2015 will not receive the Notice of Election.

Eligible Unitholders who wish to participate in the **DRP** must complete, sign and return the Notices of Election (and Tax Declaration Forms, if applicable) to the Unit Registrar, Boardroom Corporate & Advisory Services Pte. Ltd. (the “**Unit Registrar**”) at 50 Raffles Place, #32-01 Singapore Land Tower, Singapore 048623 (Telephone number: +65 6536 5355).

The Notices of Election (and Tax Declaration Forms, if applicable) must be received by the Unit Registrar by **5.00 p.m. on 20 May 2015**, and may not be withdrawn or cancelled upon receipt. Notices of Election (and Tax Declaration Forms, if applicable) received after 5.00 p.m. on 20 May 2015 will not be processed.

The 4Q FY2014/15 Distribution will be paid on 4 June 2015. The new Units issued pursuant to the **DRP** (the “**New Units**”) are expected to be listed on the Singapore Exchange Securities Trading Limited (the “**SGX-ST**”) on 4 June 2015. Eligible Unitholders who do not elect to participate in the **DRP** and Overseas Unitholders who do not provide registered addresses in Singapore to **CDP** will receive all of their respective entitlements to the 4Q FY2014/15 Distribution in cash.

<sup>1</sup> “**Notice of Election**” means the one or more notices of election (in such form as the Manager may approve) which the Manager will, at its discretion, send to each Unitholder and through which each Unitholder may indicate whether they wish to participate in the Distribution Reinvestment Plan.

<sup>2</sup> “**Tax Declaration Forms**” means the “Declaration for Singapore Tax Purposes Form A and Form B (and its annexes)” which are sent to all Unitholders except individual Unitholders.
