**CORRIGENDUM TO THE COMPANY’S ANNOUNCEMENT RELEASED ON SGXNET ON
13 AUGUST 2026 ENTITLED “RESPONSES TO SGX QUERIES”**

The Board of Directors (the “Board”) of AJJ Medtech Holdings Limited (the “Company”, and together with its subsidiaries, the “Group”) refers to the Company’s announcement entitled “Responses to SGX Queries” released on SGXNet on 13 August 2026 (the “Announcement”).

The Company wishes to inform shareholders and investors of the following inadvertent drafting and typographical errors contained in the Announcement and the corresponding corrections thereto (collectively, the “Corrections”):

1. Introductory paragraph on page 1 of the Announcement

The introductory paragraph on page 1 of the Announcement was incorrectly stated as follows:

“The Board of Directors (the ‘Board’ or the ‘Directors’) of AJJ Medtech Holdings Limited (the ‘Company’, and together with its subsidiaries, the ‘Group’) refers to the following queries by the Singapore Exchange Securities Trading Limited (the ‘SGX-ST’) on 11 Aug 2026. Unless otherwise defined, capitalised terms used in this announcement shall have the meanings ascribed to them in the Company’s announcements dated 30 June 2025 relating to the Notice of Termination of Distributorship Agreement.”

The aforesaid introductory paragraph should be deleted in its entirety and replaced with the following:

“The Board of Directors (the “**Board**”) of AJJ Medtech Holdings Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) refers to the queries raised by the Singapore Exchange Securities Trading Limited (the “**SGX-ST**”) on 11 August 2026 and sets out below the Company’s responses thereto.”

2. Sponsor’s contact address on page 3 of the Announcement

The Sponsor’s contact address appearing on page 3 of the Announcement was incorrectly stated as follows: “160 Robinson Road, #20-01/02, SBF Building, Singapore 068914, Singapore 068906.”

The correct address should read as follows:

For the avoidance of doubt, the Board confirms that the Corrections are confined solely to the matters set out above and do not alter or affect the substance of:

- (a) the queries raised by the SGX-ST;
- (b) the Company’s responses thereto; or
- (c) the assessments and conclusions of the Board and the Nominating Committee in relation to Mr Chong Eng Wee as set out in the Announcement.

Save for the Corrections, all other information contained in the Announcement remains unchanged.

For ease of reference, a clean revised copy of the Announcement incorporating the Corrections (the “Revised Announcement”) is attached to this corrigendum. The Revised Announcement shall supersede the version of the Announcement released on SGXNet on 13 August 2026.

Shareholders and investors should read this corrigendum together with the Revised Announcement.
