## ANNOUNCEMENT

### **S\$120,000,000 PERPETUAL SECURITIES ISSUED ON 19 JUNE 2017 (ISIN No. XS1632471352)**

LMIRT Management Ltd. (the “**Manager**”) refers to the optional payment notice dated 10 June 2024 (the “**Optional Payment Notice**”). Terms used and not defined in this announcement are used with the same meanings ascribed thereto in the optional payment notice.

As set out in the Optional Payment Notice dated 10 June 2024, notice under Condition 4(j)(i) has been given to the holders of the S\$120,000,000 Perpetual Securities issued on 19 June 2017 (ISIN No. XS1632471352) (the “**Perpetual Securities**”) that Perpetual (Asia) Limited (in its capacity as trustee of Lippo Malls Indonesia Retail Trust) (the “**Issuer**”) has elected not to pay the Distribution that was scheduled to be paid on 19 June 2024 (the “**June 2024 Distribution**”). Accordingly, the Issuer has no obligation to pay the June 2024 Distribution and the unpaid June 2024 Distribution is non-cumulative and does not accrue distribution.

As a result of the exercise of this discretion, the dividend stopper provisions under the Perpetual Securities are applicable. Under Condition 4(j)(iv), the Issuer shall not:

- (A) declare or pay any dividends, distributions or make any other payment on, and will procure that no dividend, distribution or other payment is made on the Units or (except on a pro rata basis) the S\$140,000,000 Perpetual Securities issued on 27 September 2016 (ISIN No. SG74H8000008) (the “**2016 Perpetual Securities**”); or
- (B) redeem, reduce, cancel, buy-back or acquire for any consideration any of the Units or (except on a pro rata basis) any of the 2016 Perpetual Securities,

unless and until a redemption of all the outstanding Perpetual Securities has occurred, the next scheduled Distribution has been paid in full, or an Optional Distribution equal to the amount of a Distribution payable with respect to the most recent Distribution Period that was unpaid in full or in part, has been paid in full; or the Issuer is permitted to do so by an Extraordinary Resolution of the Perpetual Securityholders.
