Following the Trustee Statement¹ regarding the removal of Sabana Real Estate Investment Management Pte. Ltd. as manager of Alpha Integrated REIT (formerly known as Sabana Industrial REIT) with effect from 7:00 p.m. on 23 October 2025, Alpha Integrated REIT Management Pte. Ltd. has been appointed as the new Internalised Manager of Alpha Integrated REIT with effect from the same time.

In connection with the above, the internalisation has been effected in accordance with the resolutions approved by Unitholders at the extraordinary general meeting held on 7 August 2023 and is completed; and the trust deed dated 29 October 2010 constituting the REIT (as amended) between the Trustee and the Manager has, pursuant to a Fourth Amending and Restating Deed dated 23 October 2025 between the Trustee and the Manager, been amended to reflect the change of name of the REIT and the Manager.
