ISSUE AND ALLOTMENT OF SHARES PURSUANT TO EXERCISE OF WARRANTS

The Board of Directors (the “**Board**”) of iX Biopharma Ltd. (the “**Company**”), and together with its subsidiaries, the “**Group**”) wishes to announce that on 28 April 2026, the Company has allotted and issued 32,000 new ordinary shares pursuant to the exercise of warrants at the exercise price of S\$0.06 per warrant share, following which the number of issued shares of the Company has increased from 1,050,720,024 shares to 1,050,752,024 shares.

The new ordinary shares rank *pari passu* in all respects with the existing shares of the Company and are expected to be listed and quoted on the Singapore Exchange Securities Trading Limited on or around 30 April 2026. Pursuant to the aforesaid exercise of warrants, a cumulative total of 19,992,579 warrants, representing 34.76% of all warrants previously issued, have now been exercised and there are 37,516,900 outstanding warrants with an exercise price of S\$0.06 for each warrant share expiring on 18 July 2026.
