ANNUAL GENERAL MEETING EXTRAORDINARY GENERAL MEETING TO BE HELD ON MONDAY, 14 SEPTEMBER 2020

1. INTRODUCTION

The Board of Directors (the "**Board**") of Accordia Golf Trust Management Pte. Ltd, in its capacity as trustee-manager of Accordia Golf Trust ("**AGT**", and as trustee-manager of AGT, the "**Trustee-Manager**") refers to:

- (a) the announcement of 21 May 2020 on the automatic time extension of 60 days provided by SGX Regco and ACRA to issuers with financial year-ends on or before 31 March 2020 to hold their annual general meetings;
- (b) the COVID-19 (Temporary Measures) Act 2020 passed by Parliament on 7 April 2020 which enables the Minister for Law by order to prescribe alternative arrangements for listed entities in Singapore to, *inter alia*, conduct general meetings, either wholly or partly, by electronic communication, video conferencing, tele-conferencing or other electronic means; and
- (c) the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) (Amendment No. 2) Order 2020 (the "Order") which was gazetted on 13 April 2020, and which sets out the alternative arrangements in respect of, *inter alia*, general meetings of business trusts ("Alternative Arrangements").

The Alternative Arrangements set out in the Order will apply to meetings convened, held and conducted from 27 March 2020 to 30 September 2020.

2. DATE OF ANNUAL GENERAL MEETING AND EXTRAORDINARY GENERAL MEETING

The Board is pleased to announce that pursuant to the Order, the annual general meeting ("**AGM**") and extraordinary general meeting ("**EGM**") for AGT will be convened and held by way of electronic means, on Monday, 14 September 2020 at 10.00 a.m. and 10.30a.m. (Singapore time) (or as soon as practicable immediately following the conclusion or adjournment of the AGM) respectively.

The Trustee-Manager's Chairman, Mr Khoo Kee Cheok will conduct the proceedings of the AGM and EGM. The Trustee-Manager will endeavor to address all substantial and relevant questions which unitholders of AGT ("**Unitholders**") have submitted in advance of the AGM and EGM prior to or during the AGM and EGM.

3. NO DESPATCH OF PRINTED COPY OF THE NOTICE OF AGM AND EGM¹ AND PROXY FORMS¹

The notices of AGM and EGM and proxy forms will be sent to Unitholders solely by electronic means via publication on our corporate website and will also be made available on the SGX website¹. Printed copies of these documents will <u>not</u> be sent to Unitholders.

4. NO PERSONAL ATTENDANCE AT THE AGM AND EGM

<u>Unitholders will not be able to attend the AGM and EGM in person</u>. Instead, alternative arrangements have been put in place to allow Unitholders to participate at the AGM and EGM. Please see paragraph 5 below for these alternative arrangements.

5. ALTERNATIVE ARRANGEMENTS

Unitholders may participate at the AGM and EGM by: (a) observing and/or listening to the proceedings at the AGM and EGM via "live" audio-visual webcast or "live" audio-only stream; (b) submitting questions in advance of the AGM and EGM; and/or (c) appointing the Chairman of the AGM and EGM, as proxy to attend, speak and vote on their behalf at the AGM and EGM.

The EGM shall commence immediately following the conclusion or adjournment of the AGM as per paragraph 2 above. Unitholders who have pre-registered for the AGM will be considered to have enrolled for the EGM.

Details of the steps for pre-registration, pre-submission of questions and voting at the AGM and EGM are set out in the Appendix to this announcement

6. UNITHOLDERS WHO HOLD UNITS THROUGH RELEVANT INTERMEDIARIES

Unitholders who hold their Units through a relevant intermediary (as defined below), other than SRS investors, and who wish to participate in the AGM and EGM by (a) observing and/or listening to the AGM and EGM proceedings through "live" audio-visual webcast or "live" audio-only stream; (b) submitting questions in advance of the AGM and EGM; and/or (c) appointing the Chairman of the AGM and EGM, as proxy to attend, speak and vote on their behalf at the AGM and EGM, should approach their respective relevant intermediary through which they hold such Units as soon as possible in order to make the necessary arrangements for them to participate in the AGM and EGM.

SRS investors who wish to appoint the Chairman of the AGM and EGM as proxy should approach their SRS operator to submit their votes by 5.00 p.m. (Singapore time) on **2 September 2020**, being 7 clear working days before the date of the AGM and EGM.

"relevant intermediary" means:

- a banking corporation licensed under the Banking Act, Chapter 19 of Singapore or a wholly-owned subsidiary of such a banking corporation, whose business includes the provision of nominee services and who holds Units in that capacity; or
- a person holding a capital markets services licence to provide custodial services for securities under the Securities and Futures Act, Chapter 289 of Singapore and who holds Units in that capacity.

APPENDIX

Steps for pre-registration, pre-submission of questions and voting at the AGM and EGM of AGT

Unitholders will be able to observe and/or listen to the AGM and EGM proceedings of AGT through a "live" audio-video webcast or "live" audio-only stream via their mobile phones, tablets or computers, submit questions in advance of the AGM and EGM and vote by appointing the Chairman of the AGM and EGM as proxy to attend, speak and vote on their behalf at the AGM and EGM of AGT to be held on 14 September 2020.

To do so, they will need to complete the following steps:
