On 5 June 2024, RHB Bank (L) Ltd ("RHB Labuan"), a wholly-owned subsidiary of RHB, disposed of 388,100 NCL Shares via market transaction for a consideration of S\$66,093.43. As a result of the above transactions, RHB's percentage level of deemed interest in NCL changed from 6.03% to 5.93%. The above amount of consideration has not taken into account the brokerage fees paid.

RHB is deemed to be interested in the 18,258,764 NCL Shares held on behalf of RHB (Singapore branch) in its RHB Bank Nominees Pte Ltd account. RHB Bank Berhad is also deemed to be interested in the 5,011,653 NCL Shares held by RHB Labuan.
