The securities were transferred to shareholders of TI in proportion to their respective shareholdings following an interim capital distribution by the Liquidator satisfied by an in-specie distribution. The shares have been credited into the respective shareholders' CDP accounts on 9 June 2016.

Tritech International Holdings Pte Ltd ("TI") had held 310,081,554 ordinary shares and 155,040,777 warrants of Tritech Group Limited ("TGL"), which equated up to approximately 58.74% of 791,865,686 ordinary shares of TGL, being the total number of voting shares (excluding treasury shares) of TGL at the date of this announcement.

Following the interim capital distribution, TI had ceased to hold shares and warrants of TGL. Save for 26,792,370 ordinary shares and 13,396,185 warrants of TGL presently held in the CDP on the behalf of TI's shareholder Wang Hong in the securities account of TI acting as a bare trustee, to be transferred to Wang

Hong at a later date, pending the opening of a CDP account in Wang Hong's name. Pursuant to s. 4(10)(a) of the Securities and Futures Act (Cap. 289) an interest in a security if the interest is that of a person who holds the security as a bare trustee is disregarded.
