ANNUAL GENERAL MEETING TO BE HELD ON 29 JULY 2022

1. Background.

The Board of Directors (the "Board") of MSM International Limited (the "Company") refers to:

- (a) the COVID-19 (Temporary Measures) Act 2020 passed by Parliament on 7 April 2020 which enables the Minister for Law by order to prescribe alternative arrangements for listed companies in Singapore to, *inter alia*, conduct general meetings, either wholly or partly, by electronic communication, video conferencing, tele-conferencing or other electronic means:
- (b) the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020 (the "Order") which was gazetted on 13 April 2020, and which sets out the alternative arrangements in respect of, *inter alia*, general meetings of companies;
- (c) the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) (Amendment) Order 2021 which extended the application of alternative arrangements in respect of, *inter alia*, general meetings of companies in the relevant order beyond 30 June 2021, until it is revoked or amended by the Ministry of Law;
- (d) the joint statement by the Accounting Corporate and Regulatory Authority, Singapore Exchange Regulations and the Monetary Authority of Singapore on 1 October 2020 providing guidance on conduct of general meetings during this period; and
- (e) guidance on the conduct of general meetings amid evolving COVID-19 situation on 4 February 2022 by Singapore Exchange Regulations.

2. Date, time and conduct of Annual General Meeting ("AGM").

The Company is pleased to announce that pursuant to the Order, its AGM will be convened and held by way of electronic means on **Friday**, **29 July 2022 at 10.30 a.m.** (Singapore time).

Representative(s) from the Board will conduct the proceedings of the AGM.

3. Annual report, notice of AGM and proxy form.

In line with the relevant provisions under the Order, printed copies of the annual report, notice of AGM and proxy form will not be despatched to members.

The annual report, notice of AGM and proxy form will be sent to members solely by electronic means via publication on our Company's website and will also be made available on the SGXNet¹.

4. No personal attendance at the AGM.

Due to the current COVID-19 restriction orders in Singapore, <u>members will not be allowed to attend the AGM in person</u>.

5. Alternative arrangements for participation at the AGM.

Members may participate at the AGM by:

- (a) observing and/or listening to the AGM proceedings via live audio-visual webcast or live audio-only stream;
- (b) submitting questions in advance of the AGM; and
- (c) appointing the Chairman of the Meeting as proxy to attend, speak and vote on their behalf at the AGM.

Details of the steps for pre-registration, pre-submission of questions and voting at the AGM are set out in the **Appendix** to this announcement.

6. Persons who hold shares through relevant intermediaries.

Persons who hold shares of the Company through relevant intermediaries (as defined in section 181 of the Companies Act 1967), including SRS investors, and who wish to participate in the AGM by:

- (a) observing and/or listening to the AGM proceedings via live audio-visual webcast or live audio-only stream;
- (b) submitting questions in advance of the AGM; and/or
- (c) appointing the Chairman of the Meeting as proxy to attend, speak and vote on their behalf at the AGM.

should contact the relevant intermediary (which would include, in the case of SRS investors, their respective SRS Operators) through which they hold such shares not less than **seven (7) working days** before the AGM in order for the necessary arrangements to be made for their participation in the AGM.
