Announcement Pursuant to Rule 706A of SGX Listing Manual

(B) Merger of 100% owned U.S. Subsidiaries

AERIA Luxury Interiors, LLC into VT San Antonio Aerospace, Inc.

AERIA Luxury Interiors, LLC (AERIA), a U.S. subsidiary specialising in VIP aircraft completions and refurbishment, has been merged with another U.S. entity, VT San Antonio Aerospace, Inc. (VT SAA), with the latter being the surviving entity. The merger, which took effect 31 August 2020, is a result of ST Engineering's strategic decision to exit the VIP aircraft completions business. Following the merger, the assets of AERIA were transferred to VT SAA, while VT SAA's maintenance, repair and overhaul business continues seamlessly.

(C) De-registration of Subsidiaries/Associated companies

(i) Silvatech Global Systems Ltd

Silvatech Global Systems Ltd (Silvatech), a subsidiary of Mobility Systems Pte Ltd, has been de-registered on 21 September 2020 as part of ST Engineering's efforts to streamline its legal organisation structure. Following the de-registration, Silvatech ceases to be a subsidiary of ST Engineering.

(ii) Keystone 2 Limited

Keystone 2 Limited (Keystone 2), a UK-incorporated subsidiary of Keystone Holdings (Global) Pte Ltd, has been de-registered on 22 December 2020 as part of corporate structure streamlining after the disposal of an aircraft asset. Keystone Holdings (Global) is a 50-50 joint venture between the Group and SJ Aviation Capital Pte. Ltd, that specialises in aircraft leasing. Following the de-registration, Keystone 2 ceases to be an associated company of ST Engineering.



The aforementioned changes are not expected to have any material impact on the consolidated net tangible assets per share and earnings per share of ST Engineering for the current financial year.
