Important Announcement - Investment by the Feeder ETF into the Fund

We, Lion Global Investors Limited (the "Manager"), are the manager of Lion-China Merchants Emerging Asia Select Index ETF (the "Fund").

We wish to announce that pursuant to Section D of the New Listing Application ("NLA"), the Fund, which was listed on SGX-ST on 11 December 2024, will be a master fund with effect from 5 February 2025 (the "Effective Date").

Under a collaboration with China Merchants Fund Management Company Limited incorporated in the People's Republic of China ("PRC") which manages the China Merchants-Lion Emerging Asia Select Index ETF (QDII) in the PRC (the "Feeder ETF"), the Fund has or will be invested into by the Feeder ETF on the Effective Date, under the SGX-SSE ETF Product Link.

We have set out the investment objectives of the Fund and the Feeder ETF as follows:-

Investment objective of the Fund

The investment objective of the Fund is to replicate as closely as possible, before expenses, the performance of the iEdge Emerging Asia Select 50 Index using a direct investment policy of investing in all, or substantially all, of the underlying Index Securities.

The Index is compiled and calculated by Singapore Exchange Limited. The Index aims to track the 50 largest and most tradable companies (i) domiciled in Emerging Asia countries; and (ii) listed in Emerging Asia countries or the US Exchanges, and is designed to provide access to growth in these Emerging Asia countries (i.e. India, Indonesia, Thailand and Malaysia).

Investment objective of the Feeder ETF

The Feeder ETF mainly seeks to minimize tracking deviation and tracking error by investing in the underlying ETF (the Fund) and closely tracking the underlying index (the iEdge Emerging Asia Select 50 Index).

Please be assured that the investment made by the Feeder ETF into the Fund does not impact how the Fund is currently managed by the Manager and no action needs to be taken on your part and your unitholdings in the Fund remain unaffected by such investment.
