Parkview Management Sdn Bhd as trustee of the discretionary trust owns 100% of the voting capital of Kien Huat International Limited which in turn owns 100% of the voting capital of Kien Huat Realty Sdn Berhad.

As such, Parkview Management Sdn Bhd as trustee of the discretionary trust is deemed interested in the Genting Singapore PLC shares held by Kien Huat Realty Sdn Berhad and Genting Overseas Holdings Limited, a wholly-owned subsidiary of Genting Berhad, a company in which Kien Huat Realty Sdn Berhad controls more than 20% of the voting share capital.
