Ltd. subject to the provisions of the SSPA.

The transfer of the CLT Manager Shares to LOGOS Manager No. 1 Pte. Ltd. was completed on 5 March 2020.

LOGOS Manager No. 1 Pte. Ltd. is a subsidiary of LOGOS Trust Holdco Pte. Ltd., which is in turn a subsidiary of LOGOS Holdco Pte. Ltd.. LOGOS Holdco Pte. Ltd. is a subsidiary of LOGOS China.

LOGOS China is a subsidiary of ARA Logistics Venture I Limited. ARA Logistics Venture I Limited is a subsidiary of ARA Logistics Partners Limited which is in turn a subsidiary of ARA Logistics (Holdings) Pte. Ltd..

Accordingly, each of ARA Logistics Venture I Limited, ARA Logistics Partners Limited and ARA Logistics (Holdings)
Pte. Ltd. are deemed to be interested in the CLT Manager Shares held by LOGOS Manager No. 1 Pte. Ltd pursuant to
