- 1. **Background:** The Board of Directors (the "**Board**") of Koh Brothers Eco Engineering Limited ("**KBE**" or the "**Company**") refers to:

 - (c) the joint statement of the Accounting and Corporate Regulatory Authority, the Monetary Authority of Singapore and the Singapore Exchange Regulation issued on 13 April 2020 (and subsequently updated on 27 April 2020, 22 June 2020 and 1 October 2020) which provides guidance on the conduct of general meetings amid the evolving COVID-19 situation during the period from 27 March 2020 to 30 June 2021; and
 - (d) the statement by the Ministry of Law issued on 6 April 2021 which further extends the duration of legislation that enables entities to hold meetings via electronic means, beyond 30 June 2021, until they are revoked or amended by the Ministry of Law.
- Date, time and conduct of Extraordinary General Meeting: The Board wishes to announce that pursuant to the Order, the Extraordinary General Meeting of the Company ("EGM") will be convened and held by way of electronic means on <u>Monday, 31 May 2021 at 10.00 a.m.</u> (Singapore Time).
