EXTRAORDINARY GENERAL MEETING TO BE HELD ON 31 MAY 2021

1. **Background:** The Board of Directors (the “**Board**”) of Koh Brothers Eco Engineering Limited (“**KBE**” or the “**Company**”) refers to:
 - (a) the COVID-19 (Temporary Measures) Act 2020 passed by Parliament on 7 April 2020 which enables the Minister for Law by order to prescribe alternative arrangements for listed companies in Singapore to, *inter alia*, conduct general meetings, either wholly or partly, by electronic communication, video conferencing, tele-conferencing or other electronic means;
 - (b) the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020 (the “**Order**”) which was gazetted on 13 April 2020 and subsequently amended on 24 April 2020, and which sets out the alternative arrangements in respect of, *inter alia*, general meetings of companies;
 - (c) the joint statement of the Accounting and Corporate Regulatory Authority, the Monetary Authority of Singapore and the Singapore Exchange Regulation issued on 13 April 2020 (and subsequently updated on 27 April 2020, 22 June 2020 and 1 October 2020) which provides guidance on the conduct of general meetings amid the evolving COVID-19 situation during the period from 27 March 2020 to 30 June 2021; and
 - (d) the statement by the Ministry of Law issued on 6 April 2021 which further extends the duration of legislation that enables entities to hold meetings via electronic means, beyond 30 June 2021, until they are revoked or amended by the Ministry of Law.
2. **Date, time and conduct of Extraordinary General Meeting:** The Board wishes to announce that pursuant to the Order, the Extraordinary General Meeting of the Company (“**EGM**”) will be convened and held by way of electronic means on **Monday, 31 May 2021 at 10.00 a.m. (Singapore Time)**.
3. **Circular, Notice of EGM and proxy form:** In line with the provisions under the Order, the Circular to shareholders dated 15 May 2021 (the “**Circular**”) containing information on the following resolutions, the Notice of EGM, and proxy form will be sent to shareholders solely by electronic means via publication on the Company’s corporate website and will also be made available on the SGX website.¹ Shareholders will need an internet browser and PDF reader to view these documents. **Printed copies of these documents will not be sent to shareholders.**

Ordinary Resolution 1 – The Proposed Subscription

Ordinary Resolution 2 – The Proposed Adoption of the POC IPT General Mandate

4. **No personal attendance at the EGM:** To minimise physical interactions and COVID-19 transmission risks, **shareholders will not be able to attend the EGM in person.** Instead, alternative arrangements have been put in place to allow shareholders to participate in the EGM, as set out in paragraph 5 below.
5. **Alternative arrangements for participation at the EGM electronically:** Shareholders may participate at the EGM by:
 - (a) observing and/or listening to the EGM proceedings via “live” audio-and-visual webcast via their mobile phones, tablets or computers or “live” audio-only stream via telephone;
 - (b) submitting relevant questions in advance of the EGM; and
 - (c) appointing the Chairman of the EGM (“**Chairman**”) as proxy to attend, speak and vote on their behalf at the EGM.

Details of the steps for pre-registration, pre-submission of questions and voting at the EGM are set out in the Appendix to this announcement.

6. **Persons who hold shares through relevant intermediaries:** Persons who hold ordinary shares of the Company through relevant intermediaries (as defined in section 181 of the Companies Act, Chapter 50), including CPF and SRS investors, and who wish to participate in the EGM by:
 - (a) observing and/or listening to the EGM proceedings via “live” audio-and-visual webcast or “live” audio-only stream;
 - (b) submitting relevant questions in advance of the EGM; and/or
 - (c) appointing the Chairman as proxy to attend, speak and vote on their behalf at the EGM,

should contact the relevant intermediary (which would include, in the case of CPF and SRS investors, their respective CPF Agent Banks and SRS Operators) through which they hold such shares as soon as possible in order for the necessary arrangements to be made for their participation in the EGM.

Shareholders will be able to observe and/or listen to the EGM proceedings through a “live” audio-and-visual webcast via their mobile phones, tablets or computers or through a “live” audio-only stream by via telephone, submit questions in advance of the EGM and vote by appointing the Chairman of the EGM as proxy to attend, speak and vote on their behalf at the EGM.
