



## SGX-ST Announcement

### **ISSUANCE OF S\$125,000,000 3.40 PER CENT. NOTES DUE 2023 PURSUANT TO THE S\$2,000,000,000 MULTICURRENCY MEDIUM TERM NOTE PROGRAMME**

Further to the announcement issued by YTL Starhill Global REIT Management Limited (the "**Manager**") as manager of Starhill Global Real Estate Investment Trust ("**Starhill Global REIT**") on 19 May 2015 relating to the pricing of S\$125,000,000 3.40 Per Cent. Notes due 2023 comprised in Series 003 (the "**Series 003 Notes**") to be issued by Starhill Global REIT MTN Pte. Ltd. (the "**Issuer**"), a wholly-owned subsidiary of HSBC Institutional Trust Services (Singapore) Limited (in its capacity as trustee of Starhill Global REIT) (the "**Starhill Global REIT Trustee**"), the Manager is pleased to announce that the Issuer has issued the Series 003 Notes. The Series 003 Notes are issued under the S\$2,000,000,000 Multicurrency Medium Term Note Programme (the "**Programme**") established by the Issuer on 8 January 2008 and are unconditionally and irrevocably guaranteed by the Starhill Global REIT Trustee. DBS Bank Ltd. and RHB Securities Singapore Pte. Ltd. are the dealers of the Series 003 Notes.

The Series 003 Notes have been assigned a rating of "BBB+" by Standard & Poor's Ratings Services. The Series 003 Notes will mature on 26 May 2023 and will bear a fixed interest rate of 3.40 per cent. per annum payable semi-annually in arrear.

The Issuer will on-lend the net proceeds arising from the issuance of the Series 003 Notes (after deducting issue expenses) to the Starhill Global REIT Trustee, who will in turn use such proceeds to refinance existing borrowings of Starhill Global REIT and/or for working capital purposes of Starhill Global REIT.

Approval in-principle has been granted by the Singapore Exchange Securities Trading Limited (the "**SGX-ST**") for permission to deal in and the quotation of the Series 003 Notes on the SGX-ST. The SGX-ST assumes no responsibility for the correctness of any of the statements made or opinions expressed or reports contained herein. Admission to the Official List of the SGX-ST and quotation of the Series 003 Notes on the SGX-ST is not to be taken as an indication of the merits of the Issuer, the Starhill Global REIT Trustee, Starhill Global REIT, their respective subsidiaries and associated companies, the Programme or the Series 003 Notes.

The Series 003 Notes are expected to be listed on the SGX-ST on 27 May 2015.

*These comprise interests in Wisma Atria and Ngee Ann City on Orchard Road in Singapore, Myer Centre Adelaide, David Jones Building and Plaza Arcade in Australia, Starhill Gallery and Lot 10 in Kuala Lumpur, Malaysia, a retail property in Chengdu, China, and five properties in the prime areas of Tokyo, Japan. Starhill Global REIT remains focused on sourcing attractive property assets in Singapore and overseas, while driving organic growth from its existing portfolio, through proactive leasing efforts and creative asset enhancements.*

*Starhill Global REIT is managed by an external manager, YTL Starhill Global REIT Management Limited. The Manager is a wholly-owned subsidiary of YTL Starhill Global REIT Management Holdings Pte. Ltd. which is in turn an indirect wholly-owned subsidiary of YTL Corporation Berhad.*
