Mr Grice joined Global Invacom in September 2020 as EMEA Engineering Director and brings over 35 years of satellite product development experience to the Group. With his appointment as the Chief Technical Officer of the Group, he is responsible for the continuous development of new technologies and products for current and future market opportunities being addressed by the Company, communicate with the stakeholders on technology advances and changes, and provide guidance and information leading to the strategic direction of the business.

Mr Anthony Taylor, CEO and Executive Chairman of Global Invacom, said:

"We very much look forward to working with Mr Blaikie and Mr Grice in their new positions to further drive Global Invacom's position in the satellite communications market. The Board would also like to express their appreciation to Mr Burrell for his contribution to the Group since 1997 and is pleased to have Mr Burrell continue acting as the Chief Risk Officer of the Group, to oversee the risk and sustainability management of the Group."
