- ENTRY INTO THIRD SUPPLEMENTAL LETTER IN RELATION TO THE DEBT-EQUITY SWAP AGREEMENT

The board of directors (the "**Board**") of Advanced Systems Automation Limited (the "**Company**" and together with its subsidiaries, the "**Group**") refers to the Company's announcements dated 8 January 2026, 13 March 2026 and 24 June 2026 ("**Previous Announcements**"), in relation to the Debt-to-Equity Swap Agreement and Supplemental Letter with Advance Opportunities Fund I ("**AOF I**") for the Proposed Debt-to-Equity Swap (as defined in the Previous Announcements).

Unless otherwise defined, all capitalised terms used in this announcement shall have the same meanings ascribed to them in the Previous Announcements.

The Board wishes to announce that the Company has on 15 August 2026 entered into a third supplemental letter agreement with AOF I in relation to the Debt-Equity Swap Agreement ("**Third Supplemental Letter**").

Pursuant to the Third Supplemental Letter, the Company and AOF I have mutually agreed to further extend the deadline for the fulfilment of the conditions precedent under the Debt-Equity Swap Agreement which falls on 15 August 2026, or such other date as the parties may agree in writing ("**Extended Long Stop Date**").

The Extended Long Stop Date shall accordingly be further extended to 31 October 2026, or such other date as the parties may agree in writing.

The Board will provide further updates to shareholders of the Company as and when there are any material developments on the above matter set out in this announcement.
