Both parties inked the collaboration today at TP's annual AquaSG'17 International Aquaculture Conference and Exhibition, in the presence of Dr Koh Poh Koon, Senior Minister of State, Ministry of Trade and Industry & Ministry of National Development.

Oceanus' Executive Director and Chief Executive Officer, Mr Peter Koh, said, "We are pleased to collaborate with the brightest minds in the aquaculture sector at TP, as part of our commitment to push the boundaries of aquaculture science and technology that is in line with our science-and-evidence farming approach.

"This puts us on track to achieve our vision to become a global premium seafood supply chain manager that is at the forefront of cutting-edge aquaculture technology. These innovative technology and farming methods will raise the bar for productive and effective farming. We look forward to a meaningful and close working relationship with TP and hope to collaborate with more of such like-minded institutions."

Oceanus and TP will collaborate in aquaculture research and development – relating to nutrition, disease detection, treatment and prevention, broodstock and seedstock growth, amongst others – and skill training for TP staff and students in Oceanus' land farms. Research activities will be conducted within the Oceanus Innovation Centre @ Temasek Polytechnic, a centre set up jointly by Oceanus and TP at both Oceanus' farms in China and TP.

Recognising the importance of technology, the Group had in April 2017 established an R&D and consultancy subsidiary, Oceanus Tech Pte Ltd ("**Oceanus Tech**"). Oceanus Tech collaborates with industry thought leaders, institutions and universities to explore sustainable and innovative farming practices. This niche allows Oceanus to remain competitive, enhance productivity and manage risks more efficiently.

Shortly after the establishment of Oceanus Tech, it secured its first consultancy project from a prominent SGX-listed agriculture group to provide R&D-related services and studies. The maiden revenue of this project was recognised in the financial quarter ended June 30, 2017.
