TEE Environmental secures Changi Airport’s waste management contracts

Appoints industry veteran to oversee the environmental business

SINGAPORE, 16 May 2019 – Mainboard-listed **TEE International Limited** (特毅国际有限公司) (“**TEE**”) and together with its subsidiaries and associated companies (“**TEE Group**”), a regional Engineering, Infrastructure and Real Estate group, today announced that its wholly owned subsidiary, TEE Infrastructure Private Limited (“**TEE Infrastructure**”), through its majority-owned subsidiary TEE Environmental Pte. Ltd. (“**TEE Environmental**”), has been awarded four waste management contracts by Changi Airport Group (Singapore) Pte. Ltd. (“**CAG**”).

The contracts entail the provision of refuse removal service by TEE Environmental at Terminal 1, 2, 3 and 4 of Singapore Changi Airport for a period of three years effective from 1 April 2019, with an option to extend for a period of two years. These contracts further strengthen TEE Environmental’s clientele base, which mainly comprises industrial and commercial clients.

Mr Lim will oversee the implementation of various strategies and initiatives for TEE Infrastructure's environmental business.

To increase awareness of TEE Infrastructure's environmental business, TEE Environmental underwent a rebranding exercise and unveiled a new look for its fleet of waste haulage vehicles and equipment such as rear-end-loaders, compactors and open-top-containers.
