PAYMENT OF MANAGEMENT FEE BY WAY OF ISSUE OF UNITS IN CAMBRIDGE INDUSTRIAL TRUST

Cambridge Industrial Trust Management Limited, as manager of Cambridge Industrial Trust ("CIT" and the manager of CIT, the "Manager"), wishes to announce that 1,429,730 units in CIT ("Units") have been issued to the Manager today. The Units were issued at S\$0.6230 per Unit, in payment of approximately S\$0.9 million of the base fee ("Base Fee") component of the Manager's management fees for the period from 1 July 2015 to 30 September 2015 ("3Q2015").

The issue price was determined based on the volume weighted average price for a Unit for all the trades done on the Singapore Exchange Securities Trading Limited ("SGX-ST") in the ordinary course of trading on the SGX-ST, for the period of ten business days immediately preceding 22 October 2015, being the date of CIT's result announcement for 3Q2015.

Following the above issue of Units, the total number of Units in issue is 1,291,767,986 of which the Manager's holding is 5,238,904.
