**PAYMENT OF MANAGEMENT FEE
BY WAY OF ISSUE OF UNITS IN CAMBRIDGE INDUSTRIAL TRUST**

Cambridge Industrial Trust Management Limited, as manager of Cambridge Industrial Trust (“**CIT**” and the manager of CIT, the “**Manager**”), wishes to announce that 1,429,730 units in CIT (“**Units**”) have been issued to the Manager today. The Units were issued at S\$0.6230 per Unit, in payment of approximately S\$0.9 million of the base fee (“**Base Fee**”) component of the Manager’s management fees for the period from 1 July 2015 to 30 September 2015 (“**3Q2015**”).

The issue price was determined based on the volume weighted average price for a Unit for all the trades done on the Singapore Exchange Securities Trading Limited (“**SGX-ST**”) in the ordinary course of trading on the SGX-ST, for the period of ten business days immediately preceding 22 October 2015, being the date of CIT’s result announcement for 3Q2015.

Following the above issue of Units, the total number of Units in issue is 1,291,767,986 of which the Manager’s holding is 5,238,904.

Cambridge Industrial Trust (“CIT”), publicly listed on the Singapore Exchange Securities Trading Limited since 25 July 2006, is Singapore’s first independent industrial real estate investment trust (“REIT”).

CIT invests in quality income-producing industrial properties and has a diversified portfolio of 51 properties located across Singapore, with a total gross floor area of approximately 8.5 million sq ft and a property value of S\$1.4 billion as at 30 September 2015. They range from logistics, warehousing, light industrial, general industrial, car showroom and workshop to business park properties, which are located close to major transportation hubs and key industrial zones island-wide.

The Manager’s objective is to provide Unitholders with a stable and secure income stream through the successful implementation of the following strategies:

- Acquisition of value-enhancing properties;
- Pro-active asset management;
- Divestment of non-core properties; and
- Prudent capital and risk management.

Cambridge Industrial Trust Management Limited, the Manager of CIT, is indirectly owned by three strategic sponsors, namely, National Australia Bank Group (“NAB”) (56%), Oxley Group (24%) and Mitsui & Co., Ltd (“Mitsui”) (20%):

Mitsui also developed the Japan Logistics Fund Inc., a publicly listed REIT in Japan dedicated to investing in distribution facilities.
