PCL holds more than 20% of the entire issued share capital of Malaysian Bulk Carriers Berhad ("MBC"). Accordingly, PCL is deemed to have an interest in the 17,954 POSH Shares held by MBC's subsidiary, Lightwell Shipping Inc ("LSI"). MBC owns the entire issued share capital of LSI. Accordingly, MBC is deemed to have an interest in the 17,954 POSH Shares held by LSI.

Accordingly and immediately after the transaction, KSL is deemed to have an interest in the shares of the Listed Issuer ("POSH Shares") held by:

- (i) 263,847,300 shares held by PCL directly;
- (ii) 13,240,000 shares held by Camsward Pte Ltd directly; and
