## **ALLOTMENT AND ISSUE OF SHARES PURSUANT TO WARRANT EXERCISE**

The Board of Directors of Second Chance Properties Ltd (the "**Company**") and together with its subsidiaries, the "**Group**") wishes to announce that the number of issued ordinary shares of the Company has increased from 748,944,052 ordinary shares to 748,972,552 ordinary shares by way of the allotment and issuance of 28,500 new ordinary shares in the capital of the Company (the "**New Shares**") pursuant to the exercise of 28,500 warrants at the exercise price of S\$0.25 per share, on 26 July 2017.
