ISSUE AND ALLOTMENT OF SHARES PURSUANT TO EXERCISE OF WARRANTS

The Board of Directors (the “**Board**”) of iX Biopharma Ltd. (the “**Company**”), and together with its subsidiaries, the “**Group**”) wishes to announce that on 17 April 2026, the Company has allotted and issued 1,230,752 new ordinary shares pursuant to the exercise of warrants at the exercise price of S\$0.06 per warrant share, following which the number of issued shares of the Company has increased from 1,048,324,529 shares to 1,049,555,281 shares.

The new ordinary shares rank *pari passu* in all respects with the existing shares of the Company and are expected to be listed and quoted on the Singapore Exchange Securities Trading Limited on or around 21 April 2026. Pursuant to the aforesaid exercise of warrants, a cumulative total of 18,795,836 warrants, representing 32.68% of all warrants previously issued, have now been exercised and there are 38,713,643 outstanding warrants with an exercise price of S\$0.06 for each warrant share expiring on 18 July 2026.
