Through Easy Direct, Mr Zhao Chichun (Executive Director of the Company) and Mr Hu Chao (Executive Director and Chief Executive Officer of the Company) each acquired 685,680 Shares (representing approximately 0.86% of total number of issued Shares), and the remaining 342,840 Shares (representing approximately 0.43% of total number of issued Shares) were acquired by other employees of the Group.
