**SUMMARY OF ELECTRICITY GENERATION VOLUME OF
POWER PLANTS FOR THE FOURTH QUARTER OF 2019**

This announcement is made by Panda Green Energy Group Limited (the “**Company**”, collectively with its subsidiaries, the “**Group**”) to keep the shareholders and potential investors of the Company informed of the latest business development of the Group. The board of directors of the Company announces that according to the Group’s preliminary operation statistics, the 58 power plants beneficially owned by the Group and its associates have generated electricity in an aggregate volume of approximately 631,006 megawatt-hour (“**MWh**”) in the fourth quarter (“**Q4**”) of 2019, and the aggregate electricity generation volume for the twelve months ended 31 December 2019 has amounted to approximately 3,172,870 MWh.
