(the "REIT Manager") has a direct interest in an aggregate of 20,054,379 Stapled Securities (the "REIT Manager's Stapled Securities") and; (iii) Frasers Hospitality Pte. Ltd. ("FHPL") has a direct interest in an aggregate of 11,668,847 Stapled Securities (the "FHPL Stapled Securities", and collectively with the FCLI Stapled Securities and the REIT Manager's Stapled Securities, the "FCL Stapled Securities"). Frasers Centrepoint Limited ("FCL") is the immediate holding company of FCLI, the REIT Manager and FHPL.

MM Group holds a 100% direct interest in each of Maxtop Management Corp. ("Maxtop"), Risen Mark Enterprise Ltd. ("RM") and Golden Capital (Singapore) Limited ("GC"). Maxtop, RM and GC collectively holds more than 20 per cent. of the issued share capital of Thai Beverage Public Company Limited ("Thai Bev"). Thai Bev holds a 100% direct interest in International Beverage Holdings Limited, which in turn holds a 100% direct interest in InterBev Investment Limited. InterBev Investment Limited holds more than 20 per cent of the issued share capital of FCL.

Accordingly, MM Group has a deemed interest in the FCL Stapled Securities, comprising a total of 408,583,778 Stapled Securities.



The manager of FH-REIT is Frasers Hospitality Asset Management Pte. Ltd. ("FHAM" or the "REIT Manager") and the trustee-manager of FH-BT is Frasers Hospitality Trust Management Pte. Ltd. (collectively with the REIT Manager, the "Managers").

FCLI was nominated by the following entities to receive the aggregate of 10,923,238 Stapled Securities issued to them as payment of management fees:
