PAYMENT OF BASE FEE BY WAY OF ISSUE OF NEW UNITS IN OUE COMMERCIAL REAL ESTATE INVESTMENT TRUST

OUE Commercial REIT Management Pte. Ltd., as manager of OUE Commercial Real Estate Investment Trust (the "Manager"), wishes to announce that 2,883,098 units in OUE Commercial Real Estate Investment Trust ("OUE C-REIT", and the units in OUE C-REIT, the "Units") have today been issued to the Manager at an issue price of S\$0.6507 per Unit (the "Issue Price").

The 2,883,098 Units were issued to the Manager pursuant to the trust deed constituting OUE C-REIT dated 10 October 2013 (as amended) (the "**Trust Deed**") as payment for 80.0% of the Base Fee (as defined in the Trust Deed) for the period from 1 January 2016 to 31 March 2016.

The Issue Price has been calculated in accordance with the Trust Deed and is based on the volume weighted average price of a Unit for all trades on Singapore Exchange Securities Trading Limited for the 10 business days immediately preceding the end of the relevant period in which the Base Fee accrues. The number of Units issued and allotted to the Manager was determined based on the Issue Price.

With the above-mentioned issue of new Units, the total number of Units in issue is 1,292,334,667, of which the Manager holds an aggregate of 36,634,667 Units.
